

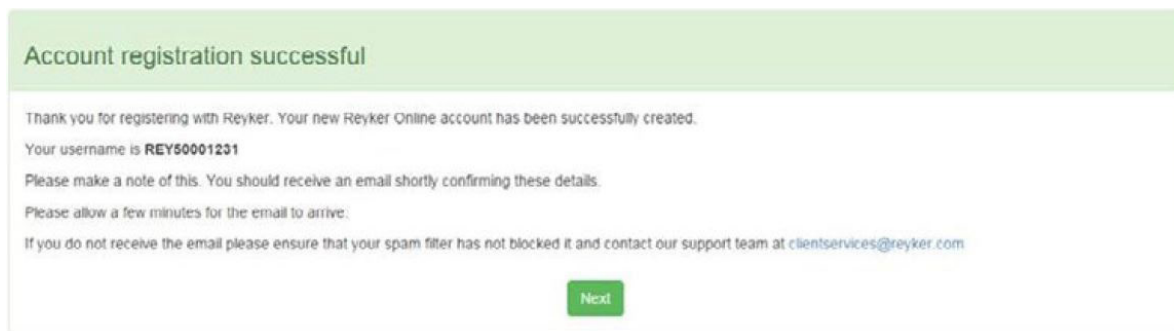

Advisor Online Registration Guide

Step 1 - Create an Advisor Account

- You can create an account with Reyker Nominees in three to four minutes online - [click here](#) to go to the registration page
- Once registered you will see the message below and will be sent two emails containing:
 1. Your unique password
 2. Your username



- Using your username and password, you can now log into Reyker's adviser portal. [Click here](#) to go to the login page
- If you have any issues logging in, [this video may be helpful](#)
- Reyker's adviser portal is the home for all your clients' documents and will allow you instant access to their welcome letters, completion statements, bi-annual valuations, annual tax statements and quarterly manager updates and commentary relating to your clients

Step 2 - Create Accounts for Your Clients

- Each client must also create an account; they can do this themselves or with you
- The client account also takes three to four minutes to complete and the client will need their **National Insurance number** and **Tax identification number** to hand
- The client will also receive two emails containing their unique username and password, allowing them to access their unique client portal

Step 3 - Submit an Application for Investment

- You can now begin to fill out an Application Form for your client, choosing either the Income or Growth options by [clicking here](#)
- The first step is to enter your client's details. Reyker will then match this to the client's account they have on file before allowing you to continue
- An application for investment takes 15-20 minutes to complete and includes:
 1. The option of ISA transfers
 2. Client suitability
 3. Adviser declaration
 4. Payment options
- Payment can be made by debit card (up to £100,000), bank transfer or cheque

Step 4 - Confirmation of Monies

- Once the Application for Investment is completed you and your clients can expect a welcome letter to say monies have been received safely and are waiting to be allotted
- This will be followed by a completion statement outlining the split of your client portfolio's investments
